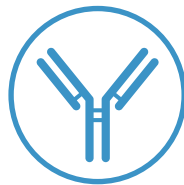

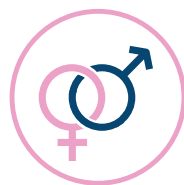

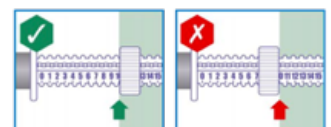

Immune system

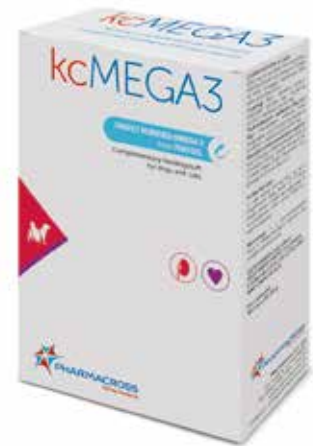
